

Procedures for the deposit and the deposit return

In the event of a **MAJOR CONSTRUCTION**, and according to the provisions of the **Sectorial Master Plan for the Management of Construction-Demolition**, Bulky and Tyre Waste Not in Use on the island of Majorca, a **DEPOSIT** must be made with the Consell de Mallorca in order to guarantee the correct construction and demolition waste management generated on site.

Steps to follow to deposit the deposit

1.



Fill in the waste form or payment document.

The construction manager or the project technician must fill in the payment document or form according to the work or project characteristics, thus obtaining the deposit that must be paid at the Consell de Mallorca. The form must be attached to the work execution project, it must be signed by the responsible technician and endorsed by the corresponding professional association.

Deposit a deposit with the Consell de Mallorca.

The person responsible for generating the construction waste must pay the deposit indicated in the waste form or payment document.

Steps to follow for the deposit return

Once the construction has been finished, and when you have the **CONSTRUCTION COMPLETION CERTIFICATE** from the council or the **ENDORSED COPY OF THE CONSTRUCTION COMPLETION**, you must request:

MAC Insular CERTIFICATE certifying the correct construction- demolition waste management, necessary to request the deposit return at the Consell de Mallorca. The procedure is available at www.mac-insular.com, under section **USERS MANAGEMENT**.

DEPOSIT RETURN at the Consell de Mallorca
